STATEMENTS DUE ON 12TH JUNE, 2019 AT 9.00 A.M

1. Comprehensive statement sought by Hon. Charles Langat on 24th April, 2019 from the Chairperson Committee on Health and Sanitation concerning expansion of health care facilities in the county. In the statement, the Chairperson should indicate;
 - a) The total amount of money allocated for the expansion of the health care facilities in the 25 wards?
 - b) Who is responsible for procurement and what is the mode of procurement applied?
 - c) The implementation status of each facility?
 - d) How many health facilities have been completed and how many are not and why?
 - e) What is the current staff allocation to each health centre? How many staff should be at the health centre at any given time both during the week days and the weekends?
 - f) What is the current status of supply of medicine in each health care facility?
 - g) Whether the composition of the current board in the health facility reflect county diversity?
 - h) How many dispensaries have been elevated to health centres and similarly how many health centres have been elevated to sub-county hospitals? Pertaining the elevation of stated health facilities indicate the Ward and Sub County where the elevated facilities are situated;
 - i) How many staff are currently working in the offices of the director of medical services and director public health to implement different programs and activities? What is the rationale used to arrive at that number?
 - j) Whether there is an approved organogram of the department of health?

2. Comprehensive statement sought by Hon. Charles Langat on 30th April, 2019 from the Chairperson Committee on Health and Sanitation concerning Universal Health Care Program. In the statement, the chairperson should indicate;
 - a) The amount of collected during the fundraising event;
 - b) The amount of money that was contributed by the county government and by other partners;
 - c) The amount of money that was used to facilitate the fundraising i.e. for publicity and advertisement before and after the fundraiser;
 - d) The number of beneficiaries that will benefit per ward and whether there was sufficient consultation on the beneficiaries;
 - e) How much money was allocated to maternal child health and how much has been used so far and whether there was sufficient consultation and public participation before the Program was rolled out.
