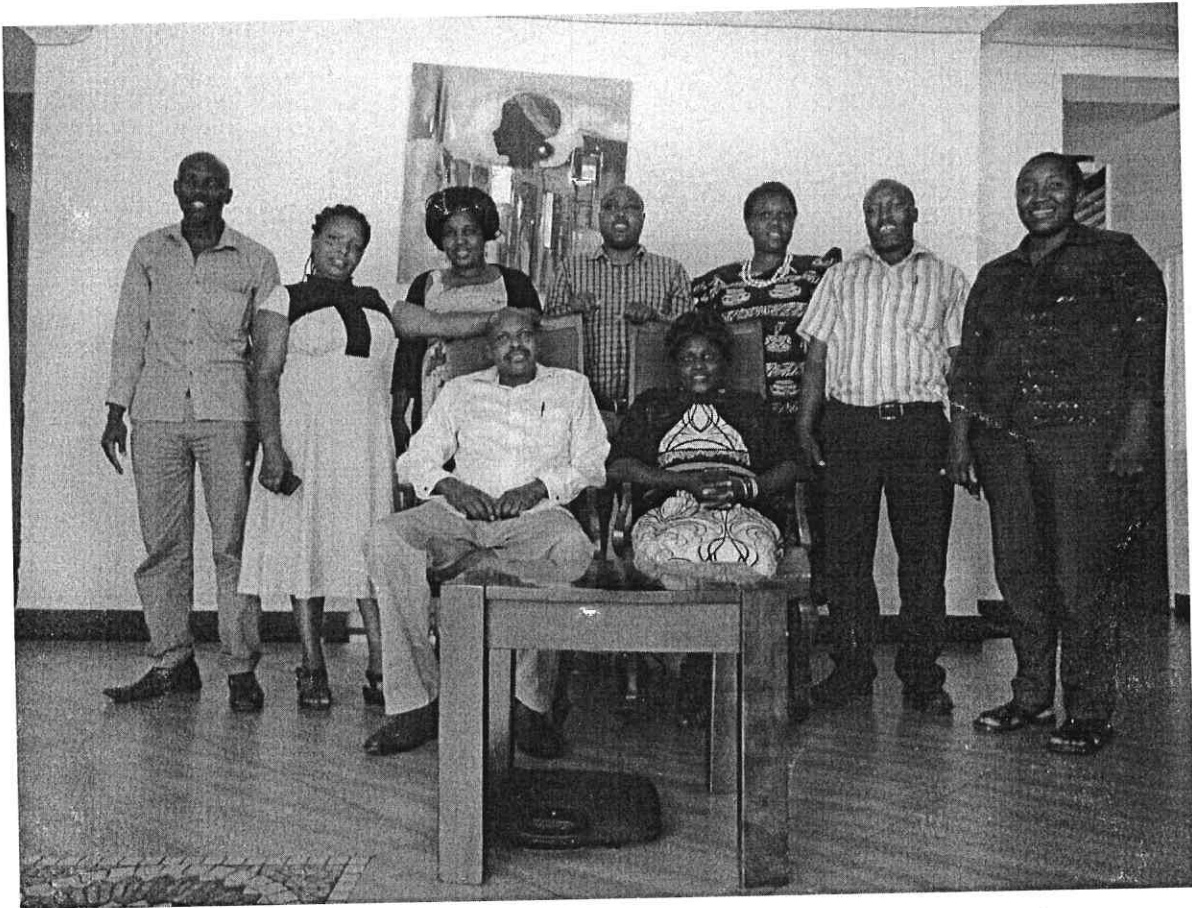

1.0 COMMITTEE'S MANDATE



The Sectoral Committee on Administration, Peace, Justice and Legal Affairs derives its mandate from provisions of Standing order 193 which provides as follows:

- a) To investigate, inquire into, and report on all matters relating to the mandate, management, activities, administration, operations and estimates of the assigned ministries and departments;
- b) To study the programme and policy objectives of ministries and departments and the effectiveness of their implementation;
- c) To study and review all legislation referred to it;

- f) To vet and report on all appointments where the Constitution or any law requires the County Assembly to approve, except those under Standing Order 187 (Committee on appointments); and
- g) To make reports and recommendations to the House as often as possible, including recommendations of proposed legislation.

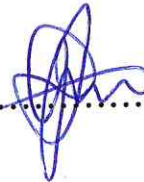

3.0 BACKGROUND



Mr. Speaker Sir,

The National Police Service Act No. 11A of 2011 provides for the establishment of the County Policing Authority.

Section 41(1) of the Act

provides that *“There shall be established a County Policing Authority in respect of each county which shall comprise -*

- a) the Governor or a member of the County Executive Committee appointed by the Governor, who shall be the chairperson;*
- b) county representatives appointed by the inspector- General, who shall comprise the heads of the National Police Service, the National Intelligence Service and the Directorate of Criminal Investigations at the county level;*
- c) two elected members nominated by the County Assembly;*
- d) the chairperson of the County Security Committee;*
- e) at least six other members appointed by the governor, from among the following categories of persons ordinarily resident in the County –*
 - i. the business sector;*
 - ii. community based organizations;*
 - iii. women;*
 - iv. persons with special needs;*
 - v. religious organization; and*

vi. *the youth.*

Section 41(2) *the members referred to in subsection (1) (e) shall be recruited through a competitive process by the office employing public officers in the County.*

Section 41(3) *the names of the members nominated under subsection (1) (e) shall be forwarded to the County security committee for vetting and subsequent thereto, the County Assembly for approval.*

Section 43(4) *further provides that in nominating and appointing members under subsection (1) (e) the nomination bodies, public service office at the county level and governor shall-*

- a) Uphold the principal of one- third gender representation;*
- b) Ensure geographical representativeness of the county; and may nominate more than one representative in respect of each category*

Section 41(5) *provide that notwithstanding subsection (1) (e), the membership of the County Policing Authority shall be **proportion to the number of constituencies in the county.***

The appointing authority shall take into account the national values referred to in Article 10 and Article 232 of the Constitution and shall reflect gender equity and ethnic diversity within that county.

In addition, the county assembly should also make some considerations pursuant to **section 7 of the Public Appointment (Assembly Approval) Act, No. 8 of 2014** which stipulates that issues for considerations by the Assembly in relation to any nomination shall be –

- a. The procedure used to arrive at the nominee;

- b. Any Constitutional or statutory (*in this case the National Police Service Act, 2011*) relating to the office in question; and the suitability of the nominee for the appointment proposed having regard to whether the nominee's abilities, experience and qualities meet the needs of the body to which nomination is being made.

Section 41 (9) of the National Police Service Act, 2011 provides for the function of the Authority to

- a. Develop proposal on priorities, objectives and target for police performance in the county
- b. Monitor trends and pattern of crime in the county including those with specific impact on women and children
- c. Promote community policing initiative in the county
- d. Monitor progress and achievement of the set targets
- e. Provide financial oversight of the budget of the county policing Authority
- f. Provide feedback on performance of the police service at the county level
- g. Provide platform through which the public participates on the all aspect to do with county policy and national police service at County level

h. Facilitate public participation on County Policing Policy

- i. Ensure policing accountability to the public
- j. Receive reports from community policing forums and committees and
- k. Ensure compliance with national policing standards

Pursuant to section (7) a person shall not qualify for the appointment if that person:

- a) Has violated the constitution
- b) Is adjudged bankrupt
- c) Is not of good character or moral standing
- d) Has not convicted a felony ; or
- e) Has not been resident or employed in the county for a continuous period of not less than three years.

The appointment of the members shall be approved by the County Assembly and shall take into account the national values referred to in Article 10 and Article 232 of the Constitution and shall reflect gender equity, geographical representativeness and ethnic diversity within that county.

Article 73 (2) of the Constitution on leadership and Integrity provides as follows:

That the guiding principles of leadership and integrity include;

- a. Selection on the basis of personal integrity, competence and suitability in free and fair elections;
- b. Objectivity and impartiality in decision making and in ensuring that decisions are not influenced by nepotism, favoritism, other improper motives or corrupt practices.
- c. Selfless services based solely on the public interest, demonstrated by-
 - i. honesty in the execution of public duties
 - ii. The declaration of any personal interest that may conflict with public duties.
 - iii. Accountability to the public for decisions and actions; and
 - iv. Discipline and commitment of service to the people.

4.0 APPOINTMENT PROCESS

Mr. Speaker, Sir,

After receiving the names of the nominee to the position of members to the County Policing Authority on 2nd September 2015, the Committee resolved to have a meeting on the 7th and 8th of September 2015 to deliberate on the work plan and procedure for the vetting exercise.

The Committee complied with the Constitutional and legal requirements and

established procedures for vetting. It ensured public participation and openness in carrying out the proceedings was adhered to. Notifications inviting the public to submit memoranda was placed in print media on 11th September 2015 in tandem with the law.

The Committee in its meeting of Monday 7th September 2015 resolved to invite the nominees to the County Policing Authority for approval hearings within the precincts of the county Assembly.

In conducting the vetting exercise, the Committee made reference to the Constitution, the National Police Service Act, No 11A of 2011, the Public Appointments (Assembly Approval) Act No. 8 of 2014), and the Standing Orders.

4.1 Issues for consideration in conducting the Approval hearing

In conducting the Approval hearing, the Committee was guided by Article 73 (2) (a) (b) (c) and (e) of the Constitution, and the provisions of Section 7 of the Public Appointments (Assembly Approval) Act No. 8 of 2014 which provides that the issues for considerations by the Assembly in relation to any nomination shall be the procedure used to arrive at the nominee and any Constitutional or Statutory requirements relating to the office in question; and the suitability of the nominee for the appointment proposed having regard to whether the nominee's abilities, experience and qualities meet the needs of the body to which nomination is being made.

4.2 Correspondence by the County Secretary

On September, 2015, the Speaker through the Clerk of the county Assembly conveyed a message to the committee on Administration, Peace, Justice and Legal from the County secretary that the governor had nominated;

1. Miss. Rose Chepkoech Rotich
2. Mrs. Ruth Chelangat Tele

To serve in the position of members of the County Policing Authority.

The curriculum vitae and certificates of the nominees were also thereafter forwarded to the Committee to conduct approval hearings.

4.3 Notification to the nominees

On 11th September 2015, the Clerk of the Assembly, pursuant to Section 6(3) of the Public Appointments (Parliamentary Approval) Act (No. 33 of 2011), notified the nominees of the time and place for holding the approval hearing through an advert in the daily nation.

4.4 Notification to the public

Further pursuant to **Section 6(9) of the Public Appointments (Parliamentary Approval) Act No. 33 of 2011**, which provides that “any person may, prior to the approval hearing, and by written statement on oath, provide the Clerk with evidence contesting the suitability of a candidate to hold the office to which the candidate has been nominated”.

In the same advert of the of the 11th September 2015, the Committee, placed notifications informing the general public of the intention of the Assembly to conduct an approval hearing, as provided for by **Article 118 (1) (a) (b) and (2) of the Constitution** and **Section 6(4)** of the Public Appointments (Parliamentary Approval) Act, 2011, which allow public participation in Committee proceedings. The Notification further gave provision for the submission of memoranda to the office of the Clerk on the suitability or otherwise of the nominee, by Thursday 17th September, 2015.

5.0 COMMITTEE MEETINGS

Following the committal of the list of the nominees to the committee by the Hon. Speaker, the committee held a meeting and came up with the below work plan:

The Committee due to the time constraints held one day vetting session on Friday 18th September 2015. However, before the nominees were invited to appear the committee held a session in order to deliberate and agree on standardized questions on the vetting in line with the Public Appointments (Assembly Approval) Act No.8 of 2014.

The committee formulated the following set of questions to be answered by the nominees.

Does the candidate meet the requirements of chapter six of the Constitution of Kenya on Leadership and Integrity? **If yes, [The Committee to verify the validity and availability of the following docs:]**

- A. ID Card/Passport
- B. Compliance Certificate from Kenya Revenue Authority (KRA)
- C. Clearance Certificate from Higher Education Loans Board (HELB)

- D. Clearance Certificate from Ethics and Anti-Corruption Commission (EACC)
 - E. Certificate of Good Conduct from Criminal Investigation Department (CID)
 - F. Clearance Certificate from Credit Reference Bureau (CRB)
 - G. Accreditations from Commission of University Education for Foreign degrees (if applicable)
1. Kindly tell us about yourself.
 2. What roles and duties do you expect to perform while serving as a county policing authority?
 3. Who are the members of the County Policing authority?
 4. What technical skills from experience point of view do you have that will solve insecurity in Bomet County.
 5. If approved and with your experience, how will you bring about change in your line of work?
 6. How many chapters are contained in the Constitution of Kenya 2010?
 7. Kindly give any three legal documents that will guide you in management of issues in your department, assuming you are now a county policing officer.
 8. Chapter Two, Article 10 (1) of the Constitution of Kenya describes the National values and principles of governance that shall bind all State organs, State officers and public officers and all persons. Under what (3) circumstances shall you be bound by these National values and principles?
 9. Kindly state these National values and principles of Governance.

6.0 SUBMISSION OF MEMORANDA

By close of business on Thursday 17th September 2015 the Committee had not received any memoranda from the public.

7.0 THE VETTING PROCESS

The committee allocated each candidate a maximum of one hour for vetting. In conducting the vetting exercise, the Committee was guided by, among other documents, the Constitution, the Public Appointments (Parliamentary Approval) Act No. 33 of 2011 and the county Assembly Standing Orders. During vetting they used the same guidelines to examine the nominee.

The Committee also followed the following criteria in vetting the nominee;

- a) Employment record and work experience
- b) Public office, political activities and affiliations
- c) Potential conflict of interest
- d) Suitability to the position
- e) Integrity

Furthermore the Nominees were also evaluated on the following areas;

- a) Technical knowledge particularly in respect to the County Policing Authority
- b) General appreciation of the Constitution

- c) Personal Presentation by the candidate
- d) General knowledge on public affairs

7.1.1 Miss Rose Chepkoech Rotich

The Committee having considered her curriculum vitae and heard her oral submission during the vetting exercise, made the following observations:-

- i. That Miss Rose Chepkoech Rotich was above average on county Policing Authority Issues and also presented herself well before the committee. She also has the requisite qualification in terms of professional experience having represent people living with disabilities in many forums.
- ii. That she was well versed with causes of insecurity in Bomet County and gave the committee the possible ways of mitigating the problems.
- iii. Her Personal Presentation before the Committee was good.
- iv. Her many years working with many organization as an educator will help her much in bringing the experience into the committee and especially during mobilizing the communities.

The Committee found **MISS. ROSE CHEPKOECH ROTICH**

SUITABLE for appointment as the member of the County Policing Authority to represent people living with disability.

7.2.1 Mrs. Ruth Chelangat Tele

The Committee having considered her curriculum vitae and heard her oral submission during the vetting exercise, made the following observations:-

- i. She attained her ordinary level certificate Div. IV in 1980.
- ii. General knowledge particularly in respect to the mandate of the County Policing Authority was relatively average.
- iii. Personal Presentation by the candidate was moderate since she could not

speaking in fluent English nor Kiswahili the national language of Kenya.

- iv. General knowledge on public affairs was fair
- v. The committee found out that the nominee was honest on the way she was responding to questions posted to her by the committee.
- vi. The nominee had the basic knowledge with regard to the application of the Constitution if appointed to represent women in the County Policing Authority but was not aware of the enabling laws such as the National Police Service Act and the County Governments Act but she indicated her willingness to learn if appointed.
- vii. The committee found her trustworthy having been the treasurer for over twenty years in a women organization.

The Committee on the basis of competitiveness and one third gender rule found out **MRS. RUTH CHELANGAT TELE SUITABLE** for appointment as the member of the County Policing Authority

8.0 FURTHER FINDINGS AND RECOMMENDATIONS OF THE COMMITTEE



Upon evaluation of the two nominees, the committee also observed that regional balance and representation as by the

Act was not observed in nomination of candidates. It was particularly notable that:

- i. Chepalungu Sub-County did not have a nominee hence regional balance was not achieved
- ii. The academic and professional qualification was not included as a requirement during advertisement of the positions.
- iii. The youths were equally not nominated to the position of Member of County Policing Authority.
- iv. That even having advertised for the public to submit the memoranda and attend public hearing there was only one member of the public Mr. Raymond Ngetich from Sotik that attended the vetting. The committee recommends that subsequent vetting, there should be public education on the importance of attending such activities.

During her oral submission she said that she is from Sugutek village Chemalal sub-location Konoin constituency and a mother of ten and currently with fifty four years.

She entered primary school in 1968 at Chepngeno primary school and did her certificate of primary education in 1978 at Chemeker primary school

In 1977 she graduated in Boito secondary school with K .C.E (Kenya certificate education) and from 1980-1985 she worked as untrained teacher

The nominees was having difficulties in answering most of the question asked by the committee and she promised to cooperate if nominated.

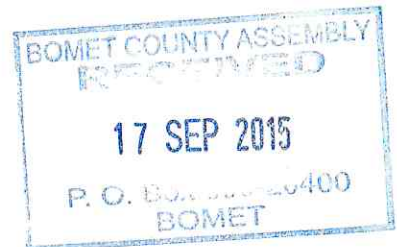

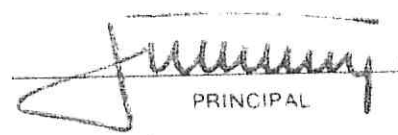

1 General Provisions

a. Language

This agreement has been drawn in English language and any notices, correspondences hereafter or statute required to be served, shall be in English.

b. Interpretation

This agreement is to be interpreted in accordance to the laws of Kenya.

c. Specific Term of Reference (ToR) for the COB:

- Planning, training and supervision of all Poll Watchers deployed in the constituency by the partners under KEDOF;
- Implement region wide strategies, performance targets and timetable and provided by the regional coordinator in consultation with the KEDOF partner.
- Report on implementation of the strategies and make any necessary adjustments in consultation and agreement with RC, your organisation and the lead partner;
- Establishing communications procedures with Poll watchers and maintain regular contacts with them;
- Meet with the poll watchers in the constituency and report on their performance and follow up on any issues arising on the election day;
- Co-ordinate with the "lead" KEDOF partner in the province/Region regarding the training of Poll Watchers;
- Organise training events for all KEDOF Poll watchers in the region in partnership and guidance from the lead partner and as directed by the KEDOF Programme Technical Board;
- Ensuring close co-operation and co-ordination with other observer groups (including international missions) to ensure full exchange of information and views;
- Liaise regularly with the COBs from the other KEDOF implementing agencies observing and reporting in the region;
- Compile a short summary report of activities in your region noting particularly any complaints, irregularities and interferences observed by or reported to you
- Forward the weekly reports from your constituency observers and poll watchers to your organisation within the stipulated time line;
- Produce a final report on the operational management of the programme in your region;
- Attend to any final evaluation programme as requested.

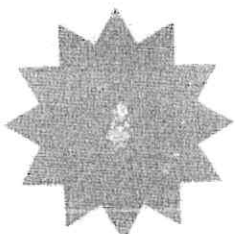

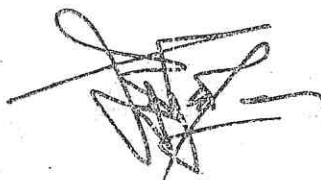

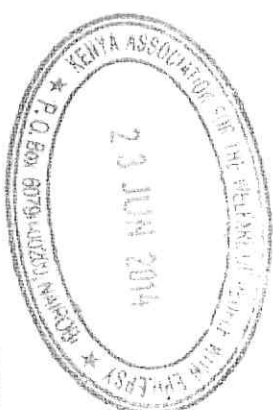
