1. That Clause 5(5) be amended by inserting the words “**vocational training**” immediately before the term “**institutions**”
2. That Clause 6(1) be amended by deleting the terms, “**ensure funds are allocated for bursary in each financial year**” and replacing thereof the words, “**ensure that there are sufficient funds allocated to the Fund**”
3. That Clause 12(3) be amended by deleting the letters **(a) to (c)** and replacing thereof with the letter “**(b)**”
4. That Clause 17(1) be amended by deleting the words “**pursuant to section 116(2) of the public finance**” and replacing thereof with the words, “**for the Fund**”
5. That Clause 18(2)(a) be deleted and the subsequent paragraphs be re-arranged accordingly.
6. That **a new clause 12 (2)(d)** be introduced with the following words, “**The term of office of members appointed under sub-section 2(b) shall be two years.**”
7. That **a new clause 31** be introduced with the following words, “**The existing County Bursary Fund Committee and all the existing Ward Bursary Fund Appraisal Committees established under sections 6(2) and 6(5) respectively of the Bomet County Support for Needy Act, 2014 shall continue in office until new committees are established under sections 12 and 18 of the Act.**”

12. That Clause 5 (1) (b) be amended by deleting the words **“or a senior office designated by the Executive Member”**
13. That **a new clause 5(1) (e)** be introduced with the following words **“Two persons appointed by the Executive Member to represent persons living with disability and non-governmental organizations.”**
14. That **a new Clause 5(3)** be introduced with the following words, **“The term of office of members appointed under sub-section 5 (1) (e) shall be two years renewable once.”**
15. That Clause 19 be amended by deleting the words **“committee”** and replacing thereof with the words **“Accounting officer designated by the County Executive Committee Member for Finance pursuant to the Public Finance Management Act.”**
16. That **a new sub Clause 20(e)** be introduced with the following words, **“Funds appropriated by the County Assembly.”**
17. That **clause 1** of the schedule be amended by deleting the words **“paragraph (a) and (f) of section”** and replacing thereof with the words, **“paragraph (e) of section 5 (1)”**
18. That **a new clause 4(4)** of the schedule be introduced with the following words **“The Committee shall elect the vice chairperson during the first meeting.”**
