Hon. K. Ngetich (Leader of Minority): Hon. Speaker, we had a deliberation on the same and with the fact that we are lacking behind in so many issues, I beg to Second.

Hon. B. Langat (Kembu ward, UDA): Hon. Speaker, Sir, thank you. I support the Motion before us. We have waited for this and it is high time this Committee passed through. I support this Motion.

Hon. S. Changmorik (Longisa Ward, UDA): Hon. Speaker, Sir, thank you. I stand to support the Motion. I thank the Leader of Majority for bringing this Motion because the Governor is yet to submit the County Executive Committee Members. This is the Committee that is going to vet them. It is prudent that we have this Committee in place so that as soon as their names come to the Assembly, we will be ready to vet them.

I thank the Leader of Majority for including me as one of the Committee members. I have gone through the list and I see that he has done a good job. That is why all the sub-counties are well represented here. I promise my colleagues from Bomet East that I will perform my duties well in this Committee. I urge the Assembly to support the Motion.

Hon. Speaker, Sir, thank you. I support.

Hon. P. Ronoh (Kipsonoi Ward, UDA): Hon. Speaker, Sir, thank you for this opportunity. I rise to support the Motion before us. This Motion is long overdue. We want this Committee in place because the activities of the County Government rely on them. However, the law that establishes this Committee is clear on the membership. I am worried because it is not gender sensitive. Out of the seven, I only see one female Member.

REPORT OF THE COMMITTEE ON SELECTION ON APPOINTMENT OF MEMBERS TO VARIOUS COMMITTEES

Hon. P. Kirui (Leader of Majority): Hon. Speaker, Sir, the next Motion is on appointment of Members to various Committees, THAT, Pursuant to Standing Order 165 (2), this County Assembly approves the report of the Selection Committee on the constitution of Committees laid on the Table of the Assembly on 13th October 2022 at 10:00 a.m.

Hon. Speaker, Sir, the County Assembly Committee on Selection is a Select Committee established under the Standing Order 165 (1) of the County Assembly Standing Orders. It is a Committee which is mandated among others to nominate Members to serve in Committees save for the membership of the County Assembly Business and Rules Committee, Liaison Committee and Committee on Appointments.

Hon. Speaker, Sir, the County Assembly Committee on Selection as currently constituted was established by the County Assembly on 12th October 2022.

Mr. Speaker Sir, the Committee as currently constituted consists of the following Honorable members;

Mr. Speaker Sir, Standing Order 165(2) provides that the Committee on Selection shall nominate members to serve in committees, save for the membership of the County Assembly Business and Rules Committee, Liaison Committee and Committee on Appointments.

Mr. Speaker Sir, the Committee having received proposals from both the Leader of Majority and the Leader of minority on the constitution of committees considered the said proposals and nominated members to serve different committees.

Section 14 (1) (b) of the County Governments Act 2012 provides that the County Assembly subject to Standing Orders made under paragraph (a), may establish committees in such manner and for such general or special purposes as it considers fit, and regulate the procedure of any committee so established.

Mr. Speaker Sir, the Bomet County Assembly Standing Orders provides for 12 sectoral committees and 8 select Committees. Section 15 of the County Assemblies Powers and Privileges Act No. 6 of 2017 also establishes the committee of Powers and Privileges.

The County Assembly Selection Committee therefore nominated members to serve in these various committees.

Mr. Speaker Sir, in nominating members to serve in the various committees, the County Assembly Committee on Selection took into consideration the criteria set out under Standing Order 167(1) of the County Assembly Standing Orders which is that in nominating Members to serve on a select committee, the County Assembly Selection Committee ensured that the membership of each committee reflects the relative majorities of the seats held by each of the County Assembly parties in the County Assembly.

Mr. Speaker Sir, Standing Order 167(3) also provides that except as the County Assembly may otherwise resolve, on the recommendation of the Committee on Selection for reasons to be stated, no member shall be appointed to serve in more than three Sectoral committees.

Mr. Speaker Sir, as required under Standing Order 16(2), the Speaker in consultation with the County Assembly Parties submitted a list of three Members for consideration by the County Assembly Business and Rules Committee as members of the Speaker's panel who would be the 1st, 2nd and 3rd Chairperson of Committees.

Hon. Speaker (Hon. C. Korir): Hon. Member it is either you support or oppose. There is nothing like partially support.

Hon. V. Rop (Nominated MCA,UDA): Hon. Speaker give me some time I explain it. Being a graduate of St Paul University, Kenya institute and Highway building technology, I come with fast experience and I think I should be in some key committee. Hon. Speaker we can do some changes.

(Hon S. Changmorik rose on a point of order)

Hon. S. Changmorik (Longisa Ward, UDA): Hon. Speaker, is it in order for the Hon Member to tell this Assembly that he has learnt a lot? We have learnt a lot as well and those in the list have e PHDs. Let the Member withdraw the Statement.

Hon. V. Rop (Nominated MCA, UDA): Hon Speaker I am not trying to in sinuate that their a\re illiterate members. It is that I have always looked for a chance to diverge the knowledge I have acquired. It was on a lighter note and I have offended Hon Changmorik I withdraw the statement. I am here of the UDA party representing g the Youth and the committee thought I am not a youth but I am ready to present my ID for scrutiny. I am willing to donate one the committees so as to join Committee on Education Youth and Sports because I have not seen any youth in that Committee. Otherwise I appreciate the committee on selection.

Hon. D. Kirui (Ndaraweta Ward, UDA): Hon Speaker I oppose the list brought forward by the Leader of Majority because...

Hon. D. Kirui (Ndaraweta Ward, UDA): I was in Committee of Education and Vocational Training but I have found myself in Committee on Powers and Privileges. I am not even aware of what it could transact in this Assembly. I wish to know the criteria they used to arrive at that list.

(Hon. P. Ronoh rose on a point of order)

Hon. P. Ronoh (Kipsonoi Ward, UDA): Mr. Speaker is it in order for honourable D. Kirui to tell this Assembly that he was in a committee. Were there other committees before us?

(Hon. D. Kirui rose on a point of reply)

Hon. D. Kirui (Ndaraweta Ward, UDA): Mr. Speaker, we had a *Kamukunji* and that is what we discussed, unless honourable P. Ronoh is not aware.

(Hon. B. Rotich rose on a point of order)

Hon. B. Rotich (Kembu Ward, UDA): Hon. Speaker, I just wish to inform honourable D. Kirui that the Committee on Selection did their job perfectly, and thus I support the Motion.

(Hon. N. Kibet rose on a point of order)

Hon. N. Kibet (Kapletundo Ward, UDA): Mr. Speaker, thank you. You know whatever we had given for ratification on the Committee on Selection, we had given out some notes so that as a member, you can pick the committee of your choice but they were just prayers. In fact, honourable D. Kirui had a prayer for a Committee on E-governance. He, as well, knows the process because he did talk to me. Leave that to rest in the Committee of the Whole County Assembly so that we start the business of the Assembly.

Thank you. I support.

Hon. Speaker (Hon. C. Korir): I want to inform the Leader of Majority that as he is addressing the Member, he should do so through the Chair. Hon. Members, if you have anything against any other Member, do not point hands or look at the direction of the other Member. You should address the Chair but not the Member directly.

(Hon. R. Ruttoh rose on a point of order)

Hon. R. Ruttoh (Chemaner Ward, UDA): Mr. Speaker, thank you. I wish to clarify and support what the Leader of Majority has done. What hon. V. Rop, who is my deputy, has raised is a matter of concern.

Hon. Speaker (Hon. C. Korir): Hon. Member, I think you are contributing for the second time.

(Hon. R. Ruttoh rose on a point of order)

Hon. R. Ruttoh (Chemaner Ward, UDA): Hon. Speaker, I am not contributing but trying to clarify something which I am seeing.

Hon. Speaker (Hon. C. Korir): That is not allowed.

(Hon. R. Ruttoh rose on a point of order)

Hon. R. Ruttoh (Chemaner Ward, UDA): Okay, Point of information Mr. Speaker?

Hon. Speaker (Hon. C. Korir): You sit then you seek.

(Hon. R. Ruttoh rose on a point of order)

Hon. R. Ruttoh (Chemaner Ward, UDA): Okay.

(Hon. B. Langat rose of order)

Hon. B. Langat (Kembu Ward, UDA): Hon. Speaker, thank you. Pursuant to Standing Order, 165 (2), and 168 (1), which give the Committee on Selection power to make all these committees across all the Members we have in this Assembly, I think we have given the powers this committee to make selection.

For the Motion which the Leader of Majority has given us, it is well equipped and well represented across all the Members, for instance, having got an opportunity to serve in the Committee on Budget, I think the Committee on Selection did their best because they have expedited the knowledge that we have to scrutinize the functions in this county. Based on that, I support this Motion.

(Hon. P. Mutai rose on a point of order)

Hon. P. Mutai (Sigor Ward, UDA): Hon. Speaker, thank you. I wish to support the Motion. I have checked and seen that all these Members have been distributed to various committees. I also wish to inform honourable V. Rop that you have told the position areas of your education and I wish to congratulate the Committee on Selection because they have given you a very powerful committee, Committee on Powers and Privileges.

For me, I cannot support or oppose because I have nothing to that effect. Is there a partiality in distribution of materials for debate?

Hon. Speaker (Hon. C. Korir): Clerk, kindly ensure that the Member is supplied with a copy of the list from the Leaders of Majority.

Hon. Member stood to speak

Hon. Speaker (Hon. C. Korir): Hon. Member, you are out of order. You address the Chair before you talk. Anyone who wish to contribute?

Hon. E. Rotich rose on a point of order

Hon. E. Rotich (Mogogosiek Ward, UDA): Mr. Speaker, thank you for this opportunity. I would wish to congratulate the team who did this work. I would wish to agree with the Committee on Selection because they really tried much they could to ensure that are expertise is tapped, for instance, I am an educationist and finding myself in the Committee on Education is a great honour and recognition on my profession.

I wish to support the Motion since we want to move forward fast tract what is still behind the schedule.

I also wish to inform my friend, honourable V. Rop that I am also a youth in that committee and as well a representative.

Mr. Speaker, thank you.

(Hon. R. Cheptoo rose on a point of order)

Hon. R. Cheptoo (Rongena/Manaret Ward, UDA): Hon. Speaker, allow me to congratulate the Leader of Majority for giving us this Motion. I wish to say I am privileged because I was among the Committee on Selection and wish to assure the Members that we sat for more than four hours to ensure we give you the right committees in various dockets. I also wish to say what we considered during selection include qualification and profession of different Members, and regional balance. I was actually expecting Members to appreciate our work.

These committees we have already given you should be fast tract because we have a lot of Assembly Business we are supposed to start. I believe that you are aware that the list of CECs has been produced and we are supposed to sit start our business.

I support the Motion as I urge other Members to support.

Thank you.

Hon. L. Rotich rose on a point of order

Hon. L. Rotich (Chesoan Ward, UDA): Mr. Speaker, thank you. I rise to support the Motion. I urge the honourable Members to be contented in the Committees they were placed. The Committee on Selection must have seen that you are capable of delivering in the committee you were placed.

When we begin business, let us work hard. I also failed to be put in Committee on Education yet I am a renowned teacher. I even have one honourable Member here and one in the National Assembly who were my students.

Because of time and work ahead of us, let us adopt the list the way it is. We will be able to deliver in all the areas we have been asked to perform our duties. Remember we are being waited by our electorates. So, we should not take a lot of time trying to pass a list which we have not even known some of their mandates.

I seek to support the motion Mr. Speaker.

3. Indicate whether the department has qualified personnel who in conjunction with NEMA will ensure compliance.
4. State whether there are estimated places of waste disposal in the stated facilities.
5. State whether the department has received any complaints from the members of the public concerning the status of waste disposal in any of the stated facilities.
