The following statements are due;

1. Comprehensive statement sought by Hon. Ambrose Koech on 13th November, 2019 from the Chairperson Committee on Labour and Public Service on the County Enforcement Officers. He wished to be specifically informed on the following;
 - i. The number of enforcement officers who were retained by the County Government in 2017 from those who served in the previous administration
 - ii. The terms of the said officers as compared with those of the enforcement officers who were employed by the current administration.
 - iii. Whether there is shortage of Enforcement officers in the County and if so, what plans does the relevant department have in place to address the issue?

2. Statement sought by Hon. Robert Serbai on 13th November, 2019 from the Chairperson Committee on Labour and Public Service concerning the devolved staff from former local authorities. In the statement, the chairperson should indicate;
 - i. The number of the said staff who are still working in the county public service and those who have retired
 - ii. The number of the said staff who have been promoted and the criteria used in their promotion.

3. Comprehensive statement sought by Hon. Alfred Langat on 6th November, 2019 from the Chairperson Committee on Labour and Public Service concerning the office of the County attorney. In the statement, the chairperson should indicate;
 - (a) Why the office has been vacant for a long period of time despite the enactment of the Bomet Office of the County Attorney Act, 2014.
 - (b) Who has been the County's legal adviser in the absence of a substantive office holder?

 - iii. The cost of works done in each of the fields
 - iv. The procedure followed in awarding the tenders
 - v. The specific contractors awarded tenders to undertake the required works

- (a) Why the department of Youth, Gender, Sports and Culture found it necessary to purchase track suits to interns?
 - (b) Whether the item had been budgeted for;
 - (c) Whether the program was in the department's procurement plan;
 - (d) The name of the supplier; and
 - (e) The total cost of the track suits

 - ii. Whether the land acquired has been developed.
 - iii. The specific contractors awarded tenders to undertake the required works

 - ii. All the programmes and development projects that have been undertaken
 - iii. The breakdown of expenditure per program to date
 - iv. The specific contractors awarded tenders to undertake the required works
 - v. The status of works undertaken by each contractor.
